There were 26 people in attendance.

1. **Welcome:** Chairperson welcomed everyone and called the Newmarket African Caribbean Canadian Association, Annual General Meeting on October 21, 2021, at 7:02p.m. She introduced the board of directors who were in attendance. The Chair recited the rules of engagement: the meeting will be recorded, microphones be muted, messages/questions/comments should be placed in the chat – Ashley will accept the questions. Members may vote by typing in the chat

for or against; all members are eligible for election to the board. Ashley will aid with the tallying of the votes.

- 2. **Land Acknowledgement** Janis Luttrell, Vice-Chairperson read the land and ancestral acknowledgment.
- 3. Apologies of Absence A quorum was established; all board members were in attendance.
- 4. **Approval of Agenda and Minutes** No corrections to the Agenda of the AGM Matthew Palomino moved the motion to approve the minutes and Alicia Katsavos seconded. No objection to the motion

-carried.

There was no correction to the AGM Minutes of October 15, 2020, acknowledged by Ashley, Pauline Jones moved that the minutes be received, and Janis Luttrell seconded. No objection to the motion.

-carried.

- 5. **Presentation:** The Chair opened the floor for the special guests representing various organizations to speak. The following representatives spoke on behalf of their organization and their association with NACCA.
 - Louise Sirisko Director of York Region District School Board expressed tremendous thanks and gratitude to NACCA who supports the Board's work. She emphasized that NACCA was an especially important partner to the Board and that YRDSB is completely dedicated to Black students and their families and making sure that the disproportional outcomes for students are closed. The mission at the YRDSB was to have a strong positive, affirming learning and working space for students. There were four accountability meetings, the Dismantling Anti-Black Racism Steering Committee of which the Chair was a member. She noted that the Chair helped the YRDSB with strategies that see a variety of actions and goals.
 - Holly Douglas SoCo Collective Holly noted that between herself and Molly, the founders of SOCO Collective which is a local group, NACCA has been incredibly supportive to SOCO and vice versa. They are committed to dismantling Anti-Black racism within the community and beyond.
 - Kolin Alexander Staff Sergeant in charge of the Diversity, Equity, and Inclusion Bureau (the Diversity Officers and Hate Crime Investigation Unit) He thanked the Chair for the invitation. He noted that he had the pleasure of working with the Chair and other members of NACCA. The Chair was very instrumental in helping, leading and admiring her for having the vision and a strong voice in the community.
 - Dawn Gallagher Murphy Constituency Manager for MPP Christine Elliot's

 Office (MP for Newmarket and Aurora) said that she was there to learn and

to take away anything for her to voice to the MPP where she could potentially act upon them from a provincial perspective.

Anonymous - Donor to NACCA - said he wanted to be involved with an organization that wanted to help create a more just society in which privilege was evenly shared and see opportunities where racism was not a factor.
 Giving was a vehicle for showing his support and he wanted to thank NACCA for the exceptional job that they were doing.

The Chair gave an overview to new members and participants of who and what NACCA stood for and against. She explained the foundation, mission, vision, the belief, and the core values.

- 6. **Chairperson's Report** The Chair noted that a copy of the presentation and Chairperson' report will be made available on the NACCA's website. In summary the Chair thanked all the volunteers, sponsors, highlighted the major accomplishments, moving forward and funding for 2021-2022. She also covered the six focus areas that NACCA was dedicated to continuing to build and engage with.
- 7. **Treasurer's Report** Alicia Katsavos **Interim Treasurer** She was honored to be a part of NACCA which was a group of extremely diligent people that were accomplishing a lot. Special thanks to Shessel & Rana, CPA Professional Corporation for providing accounting services to NACCA. A copy of the NACCA full Financial Statement as of December 31, 2020, can be found on the website. She stated that every new venture has a goal in mind and that's growth which NACCA has accomplished.

Highlights of the Financial Statement:

- **Revenue** NACCA managed to grow revenue from 2019-\$16011 to 2020-\$26,810 a 67% increase
- **Cost** Operating expenses a slight increase of 3%, 2019- \$14,237 to 2020-\$14628 which allows to increase the excess revenue over expenditure from 2019-\$1774 to 2020-\$12182.

Explanation of Revenue vs Operating expenses: Goods and Services \$5008 consist of educational workshops, Ujamaa Marketplace, mask and hoodie sales), membership income \$275, subsidies and grants \$3673 - Federal grants for BHM, donations \$17854 - received from NACCA community, individuals, organizations and businesses. Thanks tothe anonymous donor of \$10,000.

The revenue was used towards performances and activities during BHM, scholarship award, advertising and promotion, workshops etc.

There was no slide for the balance sheet, however, at the end of 2020 NACCA held \$62,229 in current asset (cash), Long Term Asset -\$5000 in Debt Securities for the association's credit card, \$1017 computer equipment - organization's laptop. Liabilities \$53,451 deferred income which was for loan and grants received in late December of 2020 for programs (mental health and food security) which will be running in 2021.

Matthew noted that the impact of the workshop and therapy programs was huge although it was only 8% of the revenue.

The Chair said the funds received were towards those programs to be spent in 2021 and reported at the 2021 AGM.

Pauline Jones moved that the NACCA Financial Statement for 2020 be received; Paulette Henry seconded. No objections. The Chair declared the motion:

- carried and that the financials were received.

8. **Election of Officers:** The Chair received nomination from the Elections committee for Alicia Katsavos for the role of Treasurer and made a call for nomination for Alric Reid as Secretary, their background was presented in the AGM package. The Chair opened the floor for nomination of any other member. Matthew moved for the nomination of Alric Reid; Janis second. Janis moved to closed nomination; Pauline second.

Matthew moved that Alicia Katsavos be appointed to the board as Treasurer, Paulette seconded. No one opposed. The Chair said the motion was carried. Alicia moved to appoint Alric to the board as Secretary; Janis seconded. No one opposed. The Chair said the motion has been carried.

9. General Business:

- 9.1 The Chair noted that the Board received a package from her for the proposal to appoint Michael Pinnock as auditor for the 2020 to 2021 fiscal years in accordance with the By-laws. All Board members attested to the package. Matthew moved that Michael Pinnock be appointed Auditor for 2020 to 2021 fiscal year; Pauline seconded.
- 9.2 To ratify the bylaw of the Newmarket African Caribbean Canadian Association from October 25, 2020 The Chair said that as of October 19, 2020, the Ontario Not for Profit Corporation Act 2010 came into effect. NACCA has revised its bylaws to be in compliance with the requirements of the ONCA. The board accepted and received the revision.
 - 1. Janis moved to receive the amended bylaws of the Newmarket African Caribbean Canadian Association; Matthew seconded.
- 9.3 The Chair gave a special "thank you" to all donors, sponsors, and volunteers
- 10. Date of the next meeting is scheduled for October 20, 2022, at 7:00 p.m.

In her role as NACCA' Chairperson, Jerisha created a strategy to build the capacity of institutions, businesses and municipal government to address and dismantle anti-Black racism through an annual training and workshop that she produces and delivers entitled, "Towards Racial Equity: Examining Anti-Black Racism in Canada". She also developed and supported the delivery of culturally-responsive programs and services to individuals and families that are adversely impacted by anti-Black racism; she continues to drive systemic change through advocacy across various institutions, including education and policing.

Jerisha is deeply committed to building community and building relationships. She is a dedicated leader who is driven by the desire to eradicate racial discrimination by cultivating and promoting an inclusive environment where social harmony, mutual respect & human dignity are realized for all.

Matthew Palomino

Born in Kingston, Jamaica, and educated at Dr. G.W.
